# "LIVING LUCKY WITH LUKE COMBS SECOND CHANCE CONTEST" OFFICIAL RULES AND REGULATIONS 

Ontario Lottery and Gaming Corporation

August 7, 2023 to October 13, 2023

## NO PURCHASE NECESSARY. CONTEST OPEN ONLY TO LEGAL RESIDENTS OF ONTARIO WHO ARE 18 YEARS OF AGE OR OLDER AS OF THE START OF THE CONTEST ENTRY PERIOD.

The Living Lucky with Luke Combs Second Chance Contest ("Contest") is sponsored by the Ontario Lottery and Gaming Corporation ("OLG"). OLG is referred to in these Official Rules and Regulations as the "Sponsor". The Contest is managed by Pollard Banknote Limited (the "Contest Manager"), acting on behalf of the Sponsor for the purposes of this Contest. The Contest fulfillment is managed jointly by Atlas Experiences, LLC (the "Contest Administrator") and Pollard Banknote Limited, acting on behalf of the Sponsor for the purposes of this Contest. Prizes and the fulfillment thereof are managed jointly by Atlas Experiences, LLC and Pollard Banknote Limited ("Prize Supplier"). Collectively, the Sponsor, Contest Manager, Contest Administrator/Prize Supplier are referred to as the "Contest Parties".

The Contest commences on August 7, 2023 at 12:00:00 a.m. ET and ends on October 13, 2023 at 11:59:59 p.m. ET (the "Contest Entry Period"). By entering this Contest, entrants accept and agree to be legally bound by these Official Rules and Regulations and the decisions of the Sponsor (and where the Sponsor designates, the Contest Manager or Contest Administrator), which are final, binding (without right of appeal) and conclusive on all matters related to this Contest.

## 1.ELIGIBILITY

1.1 The Contest is available in Ontario only and only open to those residing in Ontario who are eighteen (18) years of age or older at the start of the Contest Entry Period ("Eligible Participant").
1.2 Notwithstanding 1.1, the Contest is not open to:
(a)Volunteers, employees, officers, directors, representatives or agents of any of the following:
(i) the Alcohol and Gaming Commission of Ontario ("AGCO");
(ii) the Sponsor;
(iii) the Sponsor's authorized Lottery Retailers (defined below in 1.3) or distributors;
(iv) the respective parent companies, subsidiaries, affiliates, prize suppliers, advertising/promotion agencies of any of the foregoing parties mentioned in (i)
(v) any entity involved in the development, production, implementation, administration, judging or fulfillment of the Contest, including the Contest Manager and Contest Administrator.
1.3 For the purpose of this Contest, a "Lottery Retailer" means a person/entity contracted by the Sponsor to sell lottery tickets and provide lottery services at a retail location.
1.4 In the event that an individual does not meet the eligibility requirements as set forth herein, the Sponsor has the right, in its sole discretion, to reject or disqualify the individual from participating in this Contest.

## 2. ODDS OF WINNING

2.1 The odds of winning a Trip Package Prize depends on the total number of all Entries (regardless of the method of Entry) submitted and received in accordance with these Official Rules and Regulations during the Contest Entry Period. Only Trip Package Prize winners will be eligible to win the $\$ 10,000$ Cash Prize or the Meet \& Greet and VIP Seating Prize. The odds of a Trip Package Prize winner winning the $\$ 10,000$ Cash Prize are approximately one in five. The odds of a Trip Package Prize winner winning the Meet \& Greet and VIP Seating Prize are approximately one in four.

## 3. HOW TO PARTICIPATE

3.1 To enter this Contest, Eligible Participants must first obtain a fourteen (14) character alpha-numeric Luke Combs Second Chance Contest Code ("Contest Code") by one of the two methods outlined below in this section 3.1, and subsequently follow the steps in section 3.2 to enter the Contest Code online to obtain Entries.

Eligible Participants can obtain a Contest Code as follows during the Contest Entry Period:
(a) With Purchase: You can receive one (1) Contest Code when you make a purchase of an eligible INSTANT LIVING LUCKY WITH LUKE COMBS lottery ticket from a Lottery Retailer in Ontario ("Eligible Purchase"). The Contest Code is located in the Luke Combs Second Chance Contest scratch-off area.

## AND/OR

(b)No Purchase Necessary ("NPN"): To receive one (1) Contest Code without making an Eligible Purchase, clearly print your first name, last name, full mailing address (street, apt./suite, city/town, province/territory, postal code) on a plain white piece of paper along with the words "LIVING LUCKY WITH LUKE COMBS SECOND CHANCE CONTEST", a one hundred (100) or more word, unique and original handwritten essay describing why you want to see Luke Combs in concert, and mail it (in an envelope with sufficient postage) along with a one (1) postage pre-paid stamped and pre-addressed envelope to: "LIVING LUCKY WITH LUKE COMBS SECOND CHANCE CONTEST", 140 Otter Street, Winnipeg, Manitoba, R3T OM8 ("Request").

To be eligible, each Request must:
(i) be received separately in an envelope bearing sufficient postage (i.e. mass mail-in Requests in the same envelope will be void);
(ii) be post-marked during the Contest Period and be received no later than September 29, 2023 (to allow sufficient time to respond with a Contest Code); and,
(iii) include all required information as noted above.

One (1) NPN Contest Code will be provided by mail to the requestor per each unique posted Request.

NPN Contest Codes may take up to 5 business days from receipt to be processed by the Contest Manager. Delivery of a NPN Contest Code is dependent on standard Canada Post delivery times (2-7 business days, depending on your location). The Released Parties (defined below) take no responsibility for any lost, stolen, delayed, illegible, damaged, misdirected, lost or destroyed Requests (all of which are void).
3.2 Once an Eligible Participant has obtained a Contest Code, they must visit OLG2ndchance.ca/LivingLucky during the Contest Entry Period to enter the Contest by following the instructions to fully complete and submit their online entry ("Entry"), including inputting their Contest Code as part of the entry process. An email address and a user password will be required to log in, update registration information and submit any subsequent Entries.
3.3 Eligible Participants will receive one (1) Entry for each unique Contest Code submitted in accordance with these Official Rules and Regulations.
3.4 Entries submitted through any other method other than that described above will be deemed invalid.
3.5 Each Contest Code is unique and can only be used one (1) time in this Contest. Sharing Contest Codes is prohibited. Each Contest Code will automatically expire after its first use or on October 13, 2023 at 11:59:59 p.m. ET (whichever occurs first).

All Contest Codes submitted are subject to verification in the sole and absolute discretion of the Sponsor. Any Contest Code that cannot be verified to the complete satisfaction of the Sponsor, in their sole and absolute discretion, is subject to immediate disqualification (in which case the Entry associated with such Contest Code will be voided).
3.6 Eligible Participants may submit a maximum of fifty-one (51) unique Contest Codes per day (defined for the purposes of these Official Rules and Regulations as 12:00:00 a.m. local time to 11:59:59 p.m. local time) during the Contest Entry Period, regardless of the method of entry.
3.7 The Sponsor reserves the right, in their sole and absolute discretion, to require proof of identity and eligibility (in a form acceptable to the Sponsor - including, without limitation, government issued photo identification): (a) for the purposes of verifying an individual's eligibility to participate in this Contest; (b) for the purposes of verifying the eligibility and legitimacy of an Entry/Request entered (or purportedly entered) for the purposes of this Contest; or (c) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with these Official Rules and Regulations. Failure to provide such proof to the complete satisfaction of the Sponsor in a timely manner may result in disqualification in the sole and absolute discretion of the Sponsor.
3.8 If it is discovered by the Sponsor (using any evidence or other information made available to or otherwise discovered by the Sponsor) that any person has attempted to: (i) use multiple names, identities, email addresses and/or any automated, macro, script, robotic or other system(s) or program(s) to enter or otherwise participate in or disrupt this Contest; (ii) falsely enter a Contest Code without obtaining a Contest Code in accordance with these Official Rules and Regulations; (iii) re-enter a Contest Code a subsequent time after its first use; and/or (iv) enter a Contest Code that has been falsified, manipulated or otherwise altered in any way (all as determined by the Sponsor in their sole and absolute discretion); then they may be disqualified from the Contest in the sole and absolute discretion of the Sponsor. Any Entry may be rejected if, in the sole and absolute discretion of the Sponsor, the online entry form is not fully completed with all required information (including providing a unique Contest Code) and submitted and received during the Contest Entry Period in accordance with these Official Rules and Regulations. The Released Parties (defined below) are not responsible for late, lost, misdirected, delayed, incomplete or incompatible Entries and/or Requests (all of which are void).

## 4. PRIZES AND PRIZE DRAWS

4.1 There are five (5) primary prizes available to be won in this Contest, each consisting of a trip to Nashville, Tennessee for the winner and their one (1) guest to attend a Luke Combs concert as further set out below ("Trip Package Prize"). Limit of one (1) Trip Package Prize per Eligible Participant. Each confirmed Trip Package Prize winner shall also be entered automatically into a secondary draw as set out below for a chance to win two (2) additional available prizes, namely one (1) ten thousand U.S. dollar (\$10,000.00 USD) cash prize (the " $\$ 10,000$ Cash Prize") awarded to one (1) Trip Package Prize winner and one (1) meet and greet and VIP seating package (the "Meet and Greet and VIP Seating Prize") awarded to one (1) Trip Package Prize winner and their guest. Collectively, the $\$ 10,000$ Cash Prize and Meet and Greet and VIP Seating Prize are referred to as the "Additional Prizes" and the Trip Package Prize, the \$10,000 Cash Prize and the Meet and Greet and VIP Seating Prize are collectively referred to as the "Prizes". For clarity, only a confirmed Trip Package Prize winner is eligible to win any Additional Prizes hereunder and there is a limit of one (1) Additional Prize per Trip Package Prize winner.
4.2 The Trip Package Prize event is scheduled to take place February 4-7, 2024 in Nashville, Tennessee. The Trip Package Prize draws will take place on or after October 17, 2023 from the total number of Entries submitted and received during the Contest Entry Period. Trip Package Prize draws will be conducted in Winnipeg, Manitoba by Pollard Banknote Limited.
4.3 For the Trip Package Prize draw, five (5) eligible entrants will be selected by an electronic random draw from among all eligible Contest Entries submitted and received during the Contest Entry Period in accordance with these Official Rules and Regulations. In addition, for each Trip Package Prize draw, five (5) eligible Contest Entries will be randomly drawn as "Back-up Entries," to be used, in the order they were drawn, in the event that the selected Contest Entry initially drawn, and/or one or more of the Back-up Entries, do not qualify as per the Official Rules and Regulations.

### 4.4 Each Trip Package Prize includes all of the following:

| Custom Living <br> Lucky with <br> Luke Combs <br> Merchandise | Custom "Living Lucky with Luke Combs" merchandise with a retail <br> value of at least fifty U.S. dollars (\$50.00 USD) for the Trip Package <br> Prize winner and their guest. |
| Private <br> Welcome <br> Reception | On the second day of the trip, there will be a private reception at the <br> Country Music Hall of Fame and Museum that will include a station <br> dinner and tokens for two drinks for each Trip Package Prize winner <br> and guest. All Trip Package Prize winners and guests will have <br> complimentary access to the tour of the Country Music Hall of Fame <br> and Museum. |
| Martin's BBQ <br> Joint Lunch <br> Buy-out | On the second day of the trip, a complimentary lunch for all Trip Prize <br> Package winners and guests at Martin's BBQ Joint. |
| Taste of <br> Nashville <br> Dinner | On day three, a complimentary station dinner for all Trip <br> Package Prize winner and their guest that will be themed to <br> Nashville and will showcase locations and the local cuisine. |


| Spending <br> Cash | Five hundred U.S. dollars (\$500.00 USD) in the form of a physical <br> check, electronic cheque or pre-paid credit card/gift card that will be <br> mailed to each Trip Package Prize winner approximately sixty (60) <br> calendar days prior to the trip start date. |

| Miscellaneous | All primary gratuities, taxes, resort fees, porter fees and maid fees are <br> included. |

4.5 The approximate retail value of the Trip Package Prize is $\$ 14,400$ USD.
4.6 There are two (2) Additional Prizes to be drawn from the confirmed winners of the five (5) Trip Package Prizes. The Additional Prize draws will take place on or around November 1, 2023, after the Trip Package Prize winners are confirmed. During the Additional Prize draw, the Contest Manager will first select one (1) of the five (5) confirmed Trip Package Prize winners by a random draw ("Draw 1"). The selected Trip Prize Package winner will receive the $\$ 10,000$ Cash Prize. Following Draw 1, the Contest Manager will then select one (1) winner by random draw from the four (4) confirmed Trip Package Prize winners who did not win the $\$ 10,000$ Cash Prize ("Draw 2"). The selected Trip Package Prize winner will receive the Meet \& Greet and VIP Seating Prize.

These Additional Prize draws will be conducted in Winnipeg, Manitoba by Pollard Banknote Limited. The winners of the Additional Prize draws will be announced at the Trip Package Prize event in Nashville between February 4-7, 2024.

The odds of a Trip Package Prize winner winning the $\$ 10,000$ Cash Prize are approximately one in five. The odds of a Trip Package Prize winner winning the Meet \& Greet and VIP Seating Prize are approximately one in four. The Additional Prizes include the following:

4.7 There is a limit of one (1) Additional Prize per confirmed Trip Package Prize winner. Eligible Additional Prize winners will be required to correctly answer a separate mathematical skill testing question at the Event prior to being confirmed as a winner.
4.8 With the exception of the proxy as mentioned in Section $5.1(\mathrm{f})$, Prizes must be accepted as awarded. There is no cash substitution available for any Prize.

## 5. PRIZE CONDITIONS

5.1 The following prize conditions apply.
a. The Trip Package Prize winner and their one guest must have a valid passport prior to departing to the Flight Destination. The Trip Package Prize winner is solely responsible for obtaining documents necessary for their respective international travel, including but not limited to, passports and travel visas.
b. The Trip Package Prizes do not include insurance, parking fees, baggage fees, alcoholic beverages (other than those served without charge at any reception and/or dinner), any items not expressly specified, and personal expenses such as telephone calls, valet service, room service, laundry, incidentals and the like, all of which shall be the obligation of the Trip Package Prize Winner.
c. The Trip Package Prize winner is solely responsible for any and all expenses, or other requirements associated with the Prize not expressly provided for herein. The Eligible Participant is responsible for arranging transportation for themselves and their guest to and from each departure airport. The Eligible Participant is responsible for air travelling together with their guest to the Flight Destination in accordance with a specified flight itinerary to be provided to the Eligible Participant as part of the Prize redemption.
d. If a Trip Package Prize winner fails to make the scheduled flight departure the Contest Administrator will attempt to rebook the flight at the cost of the Trip Package Prize winner. Any prize element, or portion thereof, that is not used due to the delay in travel will be forfeited.
e. If the Trip Package Prize winner fails to show at the designated time and place for any component of the Trip Package Prize activities, that portion of the Trip Package Prize will be forfeited. Any cash prizes awarded to Trip Package Prize winners at the Concert that are not in attendance when their name is announced will be contacted and arrangements will be made to claim and award the prize to the selected prize winner not in attendance.
f. At the request of a Trip Package Prize winner, and with the approval of OLG, a Trip Package Prize winner may appoint a proxy to travel to the Flight Destination and participate in their place. If such request is made prior to the booking deadline, such request will be at no additional cost to the Trip Package Prize winner. If such request is made after the booking deadline and a charge is imposed for changing arrangements, the Trip Package Prize winner will be responsible for paying all additional direct charges imposed by the Hotel or Airline. Proxies will receive no monetary sums; all such sums will be provided to the Trip Package Prize winner. In the event that an originally named proxy cannot attend, a second proxy may be named provided that no booking deadlines have passed at the time of the request. All proxies and any guests will be required to sign a declaration and release acceptable to the Contest Parties.
g. A Trip Package Prize winner must be at least eighteen (18) years of age. A Trip Package Prize winner is solely responsible for the actions of guest(s) accompanying the Trip Package Prize winner on the trip.
h. The Trip Package Prize winner, their proxy and/or guest(s) must have a valid credit card to be recorded with the Hotel for all incidentals at the Hotel.
i. Eligible Participants understand and acknowledge that each component of the Prize and the use thereof may be subject to a separate set of third-party terms and conditions, including but not limited to rules, regulations, restrictions, terms and conditions indicated on any tickets associated with the Prize, in force at the venues hosting the events, as part of air travel to and from the Flight Destination, as part of the Eligible Participant's and their guest's stay at the hotel for Accommodations, and any health and safety polices or protocols associated with any of the foregoing (e.g., COVID-19 testing requirements, vaccination requirements and proof, social distancing requirements, requirements for face coverings, etc.) ("Third Party Terms"). The Eligible Participant is responsible for determining the Third Party Terms applicable to the Prize (or component thereof) and their use thereof and hereby agrees to comply with such applicable Third Party Terms. OLG does not make and expressly disclaims any representations or warranties with respect to any Prize component and expressly disclaims any responsibility or liability to an Eligible Participant for any Prize component. The Eligible Participant and guest are solely responsible for complying with Third Party Terms; failure to do so may result in forfeiture of the Prize.

## 6. WINNER NOTIFICATION

6.1 The Contest Manager will attempt to contact the selected entrants at the telephone number and/or email address provided with their registration information for five (5) business days following the date of the draw in order to confirm eligibility and contact information. A minimum of four (4) attempts to contact using telephone calls and emails will be made at different times between 9:00 a.m. and 9:00 p.m. Eastern Time. The selected entrant must return any message left by the Contest Manager within the time frame stipulated in the message to remain eligible to receive the applicable Prize. Prize fulfillment details will be provided at the time of contact.

For the Trip Package Prizes and the Meet and Greet and VIP Seating Prize, the Contest Manager will then provide the Contest Administrator with the selected entrants' confirmed contact information in order for the Contest Administrator to fulfill the Trip Package Prizes and the Meet and Greet and VIP Seating Prize. The winner pack will be mailed to the Trip Package Prize winners within thirty (30) days of names being provided to Contest Administrator and will detail the prize, timelines, forms, and how they should contact the Contest Administrator to have their prize fulfilled.

The winners of the $\$ 10,000$ Cash Prize and the Meet and Greet and VIP Seating Prize draws will be announced at the Trip Package Prize event in Nashville between February 4-7, 2024. The Meet and Greet and VIP Seating Prize will be fulfilled at the Luke Combs concert.

For the \$10,000 Cash Prize, the Contest Manager will fulfill the prize within ten (10) days of the Trip Package Prize event.
6.2 If the selected entrant cannot be contacted within five (5) business days from the applicable draw, or if there is a return of any notification as undeliverable, then they may, in the sole and absolute discretion of the Sponsor, be disqualified (and, if disqualified, will forfeit all rights to the applicable Prize) and, in the case of the Trip Package Prize Draw, the Sponsor reserves the right, in its sole and absolute discretion and time permitting, to select the next available Back-up Entry according to the order in which it was drawn (in which case the foregoing provisions of this section shall apply to such newly selected entrant). For certainty, no Back-Up Entries will be drawn for the Additional Prizes in the event a selected entrant cannot be contacted in accordance with this Section 6.2.
6.3 If no confirmed winner is declared after all five (5) Back-up Entries are used in accordance with these Official Rules and Regulations, then the applicable Prize will not be awarded in this Contest.

## 7. SEPARATE ATLAS CONTEST DISCLAIMER

7.1 Each Trip Package Prize winner will have the opportunity to enter a separate, multijurisdictional contest for a chance to win five hundred thousand U.S. dollars (\$500,000.00 USD) (the "Atlas Contest"). THE ATLAS CONTEST IS SUBJECT TO ITS OWN RULES AND REGULATIONS AND IS SPONSORED AND ADMINISTERED SOLELY BY ATLAS EXPERIENCES LLC ("ATLAS") AND IS NOT IN ANY WAY A PART OF THIS CONTEST OR SPONSORED BY OR AFFILIATED WITH OLG. OLG EXPRESSLY DISCLAIMS AND IS HEREBY RELEASED FROM ANY AND ALL LIABILITY OR RESPONSIBILITY WHATSOEVER IN RELATION TO ANY CLAIM ARISING IN CONNECTION WITH THE ATLAS CONTEST, INCLUDING IN RESPECT OF THE PROMOTION, ADMINISTRATION, USE OR AWARDING OF ANY PRIZES, AND/OR ANY TAX CONSEQUENCES THEREUNDER. ANY TRIP PACKAGE WINNER WHO CHOOSES TO PARTICIPATE IN THE ATLAS CONTEST IS RESPONSIBLE FOR COMPLYING WITH ANY RULES ASSOCIATED WITH SAME AND SHALL BE RESPONSIBLE FOR ANY TAX LIABILITY THEY MAY INCUR IN ASSOCIATION WITH ANY PRIZING THEREUNDER.

## 8. PERSONAL INFORMATION

8.1 By entering this Contest, each Eligible Participant acknowledges and authorizes the Contest Parties to use collected personal information for the purpose, or consistent purpose, of administrating the Contest in accordance with the Sponsor's Privacy Policy on https://www.olg.ca/en/privacy-and-cookie-policy.html.

## 9. TERMS OF ACCEPTANCE

9.1 The Prizes must be accepted as awarded. No substitution, assignment or transfer of a prize is permitted, except at the Sponsor's sole discretion and any unclaimed prizes will not be awarded.
9.2 The selected entrant acknowledges that the Sponsor and all involved advertising and promotional agencies, the Contest Manager, the Contest Administrator, other suppliers providing prizes or other materials or services in connection with this Contest, anyone else involved in the development or execution of this Contest, each of their respective parent companies, subsidiaries and affiliated companies and each of their respective shareholders, members, directors, officers, employees, agents, representatives, successors and assignees (the "Released Parties") have not been made, nor are in any manner responsible for, any warranty, representation or guarantee, express or implied, in fact or in law, relative to any prize, including, but not limited to, its quality, merchantability and fitness for a particular purpose. Further, no responsibilities are accepted for any additional expenses, omissions, delays, re-routing, or acts of any government or authority.
9.3 Before being declared a confirmed winner of any Prize, the selected entrant will be required to sign and return within five (5) business days of receipt a declaration and release form, which (among other things): (a) confirms compliance with the Official Rules and Regulations (b) acknowledges acceptance of the applicable prize (as awarded); (c) releases the Released Parties from any and all liability in connection with this Contest, their participation therein and the awarding of the applicable prize; (d) agrees to the publication, reproduction or other use of their name, address, voice, statements about the Contest or photograph or other likeness without further notice or compensation, in any publicity or advertisement carried out by or on behalf of the Sponsor in any manner whatsoever, including print, broadcast or the internet; and (e) requires the eligible selected entrant to correctly answer a mathematical skill-testing question without the use of any mechanical aid in order to be named the winner and receive the applicable prize. Without limiting the generality of the foregoing, the Sponsor reserves the right, in its sole and absolute discretion, to administer an alternative test of skill as it deems appropriate based on the circumstances and/or to comply with applicable law.
